ONVZ Basic Health Care Plan

Insured parties aged 18 years and above have a compulsory excess of € 375. A voluntary excess is also possible. Together, the compulsory and voluntary excesses make up the total excess per year. Insured parties under 18 do not pay a premium for the Vrije Keuze Basisverzekering and have no compulsory excess. It is also not possible for them to opt for a voluntary excess.

A surcharge of 25% on the monthly premium applies to insured parties resident in the USA or Canada, with the exception of the Vrije Keuze Basisverzekering and the Privé Kamer.

Children's Premiums

You will only need to pay a premium for a maximum of 2 children up to the age of 17 years for Vrije Keuze Topfit and Superfit.

Fiscal levy

Pay in advance for extra discount
 - quarterly: 1% discount
 - half yearly: 2% discount
 - yearly: 3% discount
